

# Phd Course: Participatory Practices in Art and Architecture (PPinAA)

#### November 12-13 2015

## **Description, Purpose & Aims**

The course, which comprises **1,0 hec** is formed in relation to a symposium, and will discuss ways in which participatory techniques can be developed within, or outside of, official public consultation in architectural or otherwise site-related processes.

The two-day symposium "PP in AA" wants to reexamine the issue of participation in contemporary art and architecture practices. In recent decades, art and architecture's engagement with concerned publics and communities have manifested in a range of different ways. These participatory efforts have also been frequently criticized by political scientists, geographers, planning theorists, architects, artists, and art theorists: instead of creating more democratic spatial processes and outcomes, it has been argued that dialogue processes fail to have long-lasting effects or even become complicit in the agenda of neoliberal urban redevelopment. Against these criticisms, it can instead be argued that a range of participatory possibilities exist today which might fruitfully be explored, even if the outcomes of such exploration is not immediately calculable. The symposium "PP in AA" attempts to reread 'participation' through the concepts of translation, listening, and urban curating. The symposium will utilize various formats, including keynote lectures, reviews of projects, participatory research actions, and roundtables.

#### **Course design and Examination**

The theme of the symposium is addressed through the participants' questions raised to the lecturers at the symposium. It is a requirement, in order to be credited for the course as a PhD student, that you participate in the main parts of the symposium. Furthermore, that you formulate beforehand, and present in the symposium, a question of relevance in written and oral format.

The course is open for the ResArc affiliated doctoral students as well as for other doctoral students. The course does not render any free accommodation, however meals are provided for without cost. Please assign to the course by sending a mail to gunnar.sandin@arkitektur.lth.se
